COMPENSATION PLAN ENHANCEMENTS

The signup process is similar to that for Freedom Select on the MVIB website.

Performance results are posted monthly on the Forex Funds, LLC website within 7-10 business days of the end of each month. Individual account statements are available at all times via your broker account in the Reports section.

MARKETING UPDATE

First, allow me to share my excitement about what the future holds for FreedomRocks in the upcoming months. With the introduction of our enhanced marketing plan, many representatives will achieve their goals. If you are asking how they will do it let me explain the simple steps to building your FreedomRocks business.

The key is duplication and duplication begins with YOU! From the first time you introduce FreedomRocks to a new prospect, you are setting up the duplication model. One of the best ways to share FreedomRocks with others initially is through the use of our Live Sponsoring calls. THE FREEDOMROCKS DEBIT CARD

Whenever I pay my restaurant bill using my FreedomRocks debit card, I'm inevitably asked, "What is FreedomRocks?" What better way to show people instantly the viability, legitimacy, and the power of FreedomRocks! What a great marketing tool for your business!

You can also receive your FreedomRocks bonuses and pay your FreedomRocks subscription via the card, and use it at points of sale and ATMs all over the world!

If you have not already applied for your card, do it now!

1. Log in to the Command Center
2. Select the My Account page on the Business Tab
3. Click the Payment Methods link in the Quick Links section
4. In the FreedomRocks Debit

Card section, click the link and enter all of the requested information

5. Submit your application

Your card will normally arrive within 30 days of application. This time may vary based on the acceptance of your initial application and shipping times.



Get your card, activate it, and maybe the next time you use your card, you'll have the opportunity to introduce someone new to FreedomRocks!

WHAT IS THE DIRECT SELLING ASSOCIATION?

If you've been a network marketer for any period of time, you're probably familiar with the Direct Selling Association, (DSA). The DSA is the national trade association of the leading firms that manufacture and distribute goods and services sold directly to consumers. More than 200 companies are members of the association, including many well-known brand names.

The Association's mission is "To protect, serve and promote the effectiveness of member companies and the independent business people they represent. To ensure that the marketing by member companies of products and/or the direct sales opportunity is conducted with the highest level of business ethics and service to consumers."

The cornerstone of the Association's commitment to ethical business practices and consumer service is its Code of Ethics. Every member company pledges to abide by the code's standards and procedures as a condition of admission and continuing membership in DSA.

The DSA Code of Ethics speaks to both the consumer and the seller. It ensures that member companies will make no statements or promises that might mislead either consumers or prospective sales people. Pyramid schemes are illegal and companies operating pyramids are not permitted to be members of the DSA.

The DSA Code of Ethics is enforced by an independent

code administrator who is not connected with any member company. The code administrator will do everything possible to resolve any complaints to the satisfaction of everyone involved, and has the power to decide on remedies.

All member companies have agreed to honor the administrator's decisions. Every member company pledges to abide by the Code's standards and procedures as a condition of admission and continuing membership in the Association. You can find a complete copy of the Code at <http://www.dsa.org/ethics>.

FreedomRocks is a pending member of the DSA. We take ethics seriously – we pledge to practice the highest standards

in business ethics, to go above and beyond the minimum requirements. We have a Code Responsibility Officer (CRO), responsible for keeping abreast of DSA member requirements under the code and helping the company remain in compliance with it.

By participating in the DSA's new Code of Ethics Communication Initiative, we'll be able to keep you informed about the contents of and updates to the Code and how it affects the direct selling industry. It's also a great way for FreedomRocks to gain recognition in the industry!



GLOBAL SUPPORT CENTER UPDATE

The FreedomRocks Global Support Center is here to serve YOU! As you know, our mission statement states that our membership comes first – that every e-mail, every phone call (and every chat) will be treated with respect and resolved to the best of our abilities. We have a staff dedicated to making sure that you receive the best service possible each and every day.



Since we opened the Global Support Center in Las Vegas 3 years ago, we've answered more than 100,000 e-mails, completed more than 2,000 chat sessions (in 6 months), and answered thousands of phone calls. In the last year and a half, we've taken steps to improve our efficiency in fulfilling your requests.

In November 2007, we implemented a new e-mail system. In September 2008, we rolled out a live chat capability.

These new tools have enabled us to achieve a 170% increase in efficiency. Thanks to our Support Center, Communications, and Training staff for all their hard work in making this tremendous achievement possible!

And now, in 2009, we're poised to deploy an online knowledgebase that will allow you to search for answers to your questions, if you're so inclined, without contacting us. We'll still provide the same world-class service via phone, e-mail, and chat – we're just adding capability that will enhance our ability to support you – our valued customer!

In each edition of the Freedom Focus, we'll feature some of the most commonly asked questions of our Support Center agents.

Here's just a sample of what you've been asking:

Q: What is the difference between a Customer and a Representative?

A: A Customer may use the products but does not occupy a position in the genealogy and is not eligible to participate in the compensation plan.

A Representative may or may not use the products, and is eligible to participate in the compensation plan. To become a Representative, the applicant purchases the Business Pro or Business Builder business opportunity packages.

Q: How do I receive my bonuses?

A: FreedomRocks pays commissions on a weekly basis. The commission period extends from midnight on Saturday through the following Saturday at midnight. Bonuses are paid two (2) weeks in arrears. Bonuses are calculated the 2nd Wednesday after the end of the pay period and mailed out the next day. Members are paid via the FreedomRocks debit card from

Payoneer Payout Solutions.

Q: How do I sign up for the Debit Card?

A: Log in to the Command Center, then go to the My Account page on the Business tab. Click the Payment Methods link in the Quick Links section. When the Payment Methods page is displayed, go to the FreedomRocks Debit Card section and apply for your card.

Q: When do I get paid for the Quick Silver and President's Circle pools?

A: The Quick Silver and President's Circle bonuses will be paid the next bonus period after the 10th of the month.

Q: What are your hours?

A: We're here Monday-Friday, 10 a.m. – 4 p.m. Pacific to answer your calls and e-mails, and 9 a.m. – 6 p.m. Pacific for live chat.

We look forward to serving you in 2009!

TRAINING NEWS

The training department is abuzz with excitement and activity! We're building a training program that will help you get your business off the ground and soaring to unbelievable heights!

Our new Fast Start training has been a great success! On the 2nd and 4th Saturday of each month at 11 a.m. Pacific, you'll learn what you need to know to get your business off the ground quickly – what to do

in the first 72 hours and the first 30 days. It's the path to success that everyone should follow!

As you know, Compliance training is now available online! Since November 2008, all new representatives have been trained using our online system. You can take the training at your own pace, and the system automatically records your score when you've completed the test!

Coming soon! We've been working diligently on our newest training, called "Representative Training." It's designed as a follow on to Fast Start training, and will teach you everything you need to know about how the business works, including the compensation plan, how new representatives are placed in the binary, how "spill" works, and much more! Watch your e-mail to find out when the training will

be available. Take advantage of all that FreedomRocks has to offer in the way of training!



COMMUNICATIONS & COMPLIANCE

So what exactly does the Corporate Communications Manager do? Well, my job is to make sure you are kept informed about everything that's going on in the company, and that's no small task. Mark is constantly looking for new ways to make the company better, whether that is through compensation plan enhancements, promotions, or new events. Keeping up with Mark and making sure you do too is my mission.

It starts with e-mail, and we've greatly enhanced our ability to communicate with our members in the past few months. We now have a weekly e-mail, called the Freedom Preview. We send it out each Monday in three languages – English, Hungarian, and Slovenian. These e-mails are the BEST way for you to stay informed – make sure you read them! You can also find them on the Communications tab in the Command Center. Be sure to promote reading them to your entire organization to stay connected with the FreedomRocks home office.

Mark's "Message from the President" also comes out of the Communications department. Audio e-mail is a great way for you to hear about what's going on – right from the President of the company!

We also have a number of e-mails that go out when new members sign up, reach new pin

levels, earn bonuses, and much more. One of the most popular among our members is the "Spill" letter that goes out when someone in your upline sponsors a new member and they are placed in your downline.

Well, what about compliance? Want to use the FreedomRocks logo in your advertising? To post your trading results on the web? To use the FreedomRocks movies on your website? Before you do, read the Advertising section in the Compliance Certification Training Course.

We do business in a highly regulated environment, and are required to be in compliance with the policies of regulatory agencies such as the NFA, CFTC, and others. To ensure that we remain in compliance, we must ensure that all of our representatives are compliant. That's why we have mandatory compliance training – it keeps you and the company safe and in business for years to come.

Our online training is easy to use, takes very little time to complete, is an open-book test, and automatically records your score – eliminating the need for you to send anything to the Support Center!

You must successfully complete the course within 60 days of joining FreedomRocks, AND annually, during the anniversary month of your join date. If you do not successfully complete the initial or annual training within the required time frame, we withhold your bonuses until you do complete the training. It's not punishment – only to ensure your compliance with our policies.

So, when you receive a notice that it's time to take compliance training, go to the Compliance Training page on the Training tab in the Command Center, click the link for the test in your language, and in just a short time, you can be compliance trained!

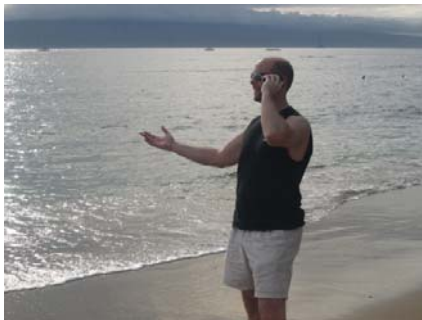

LEADERSHIP PROFILE: IBOLYA BACHMER, OUR NEWEST 1-STAR PLATINUM!



Congratulations to FreedomRocks' newest 1-Star Platinum, Ibolya Bachmer of Hungary!

We asked Ibolya to share some words about her personal life and her success in FreedomRocks. We're happy to reprint her e-mail to us here.

I am really happy to share my experiences with everybody who is looking for financial freedom.

I am the 12th child in a family of 13 children. As you can imagine, I realized that if I wanted to achieve something, it would take a deep faith, serious study, hard work, and persistence.

I am an economist by profession. I worked nearly 20 years for government agencies, and later I established my own company, representing huge investors and projects.
